Mama Cash supports **ambitious feminist organisations and initiatives**, led by women, girls and trans people, and women funds. Mama Cash is oriented for 3 main directions – Body, Money and Voice.

In 2016 Mama Cash is expecting to give out approximately 20 new grants. This call is not relevant to those currently receiving funds from Mama Cash.
