#### Technical support

### COVID-19 pandemic related TS

Technical support topics include:

- Vaccine procurement advocacy negotiations with manufacturers, support of tender procedures.
- Elimination of legal and regulatory barriers to the procurement and import of vaccines to the country.
- Prioritization of groups for vaccination, inclusion of key populations to prioritized groups, and optimization of the vaccination process based on vaccine availability and the public vaccination demand.

Information support of the national vaccination campaign, the formation of a positive attitude towards vaccination.

#### B Who is eligible to request such TS?

Representatives of NGOs and initiative community-based groups from EECA countries (Russian Federation, Moldova, Ukraine, Belarus, Kyrgyzstan, Kazakhstan, Uzbekistan, and Tajikistan) could request technical support. Applications from representatives of state bodies from the countries of the EECA region will also be considered.

#### How to request TS?

The applicant organization should send a TS request to the contact indicated above (Yevheniia Kononchuk, e.kononchuk@network.org.ua) with the following information:

- Information about the organization requesting technical support.
- Clear request with description of the problem, which is to be resolved through technical support requested and the expected results of such technical support.
- What key and vulnerable populations will be covered with such technical support?
- What other organizations have already provided technical support at such request (with a description of the results achieved).
- Deadline for providing the technical support.

The Network will respond on TS availability within 10 business days. If the request is approved, the Network will appoint an expert to follow-up on the request and will undertake obligations to provide support in the scope and within the terms agreed with the organization requesting TS.

Requests could be submitted in Russian or English. There is no formal TA request form to complete.

# Other TS options available

Overcoming human rights-related barriers to accessing HIV prevention, treatment and care services:

- Monitoring and analysis of national legislation containing provisions on criminal / administrative liability for putting at risk of infecting and transmission of HIV, and developing draft papers on amending the respective laws and bylaws.
- Advocacy of legislative amendments aimed at decriminalization of HIV transmission.
- Legal support in cases related to criminalization of HIV transmission.
- Training programs and mentoring support for community-based paralegals on legal support in cases on violation of the rights of PLHIV related to the criminalization of HIV transmission.

Optimization of HIV treatment:

- analyses of main treatment schemes and forming recommendations on changes in accordance to the latest WHO's recommendations;
- workshop/seminar for medical specialist of the latest WHO's recommendations on HIV treatment and/or testing.

Review and improvement of the national supply and procurement system:

- expert review of current national laws and practical mechanism;
- training/workshop/seminar to define an optimal national procurement system for a country.

Representatives of NGOs and initiative community-based groups from EECA countries (Russian Federation, Moldova, Ukraine, Belarus, Kyrgyzstan, Kazakhstan, Uzbekistan, and Tajikistan) could request technical support. Applications from representatives of state bodies from the countries of the EECA region will also be considered.

## How to request TS?

- The website offers freely accessible resources on COVID-19, also in Russian, and a specific set of information on COVID19 in prisons. *Capacity building, mentoring, training etc. are available at cost.*
- Programmatic interventions or trainings are available to community-based organizations, networks of (I)NGOs, and governmental stakeholders *at cost*.

## **Emergency Support Fund for Key Populations in Eastern Europe and Central Asia**

AFEW International and Aidsfonds have announced the call for applications for emergency grants in the framework of the Emergency Support Fund for Key Populations. The activities of the Fund are financed by the Elton John AIDS Foundation and Aidsfonds.

The Emergency Support Fund for Key Populations in EECA strives for a comprehensive response to emergencies threatening HIV service provision for key populations in Eastern Europe and Central Asia.

The Emergency Support Fund for Key Populations in EECA is aiming to contribute to the following goals:

- Goal 1. Decline in annual number of new HIV infections in the EECA region.
- Goal 2. Everyone living with HIV in the EECA region receives treatment .
- Goal 3. Full funding of the AIDS response in EECA.

Through small grants to registered and non-registered NGOs and CBOs, working in the area of HIV and human rights, with activities ranging from advocacy and prevention, to treatment and care in terms of HIV and co-infections, based in countries of the EECA region, AFEW International and Aidsfonds respond to fast-growing HIV epidemic in this region.

The Fund aims at supporting 80-100 organisations in the EECA with small grants in the period of 2019-2021. The maximum amount per grant is € 8.000. Only applications with a strong sustainability plan can be awarded the maximum amount, whereas the costs of the sustainability activities cannot exceed € 3.000 or account for more than 37.5% of the total amount of the grant.

The Fund will be operational until December 2021; activities funded with an ESF grant should finish no later than October 1, 2021.

## AC is a for-profit organization and is able to address a TS request only if there is a donor of funds that is able to cover the costs.

In case the requestor hasn't the available funding for the TA needed, jointly with Alliance Consultancy they will work together to find funding opportunities for it.

In general, the key aim of ATAC is to facilitate high quality technical support provision to raise effectiveness of national, regional and global responses to public health issues and HIV/AIDS and tuberculosis in particular.

#### THE KEY TECHNICAL AREAS THAT ATAC SPECIALIZES

Managerial aspects of HIV interventions including:

- · Governance and overall management of programs (including civil society, PLHIV, and KAP representation mechanisms).
- Financial management and ensuring appropriate use of resources. Management of capacity development efforts and technical support delivery. Management of sub-awards.
- Procurement and supply management.
- Risk management.
- Management of transitions from external to domestic (including governmental) funding in.

#### **TECHNICAL ASPECTS OF HIV PREVENTION, CARE AND TREATMENT**

- Ensuring expedient access of key affected populations, specific segments within those, and their sexual partners to the continuum of HIV prevention, care and treatment services.
- Ensuring that specific obstacles hindering smooth transitions of people between different levels of treatment cascade are identified and addressed through innovative solutions involving collaboration between various sectors and organizations.
- Promoting the dialogue between governmental agencies and civil society actors based on clear distribution of labor, including better understanding of the role of community-based outreach as a gateway to the complete service continuum for many key population members.
- · Use of new technologies including rapid HIV and CD4 testing to improve the effectiveness of treatment cascade.
- Revision of classic components of HIV prevention and care work with key populations such as needle and syringe programs, opioid substitution treatment, and case management in order to address changes in the drug scene, better understanding of factors affecting access to services and functioning of social networks.
- Revision of understanding of the quality of work (e.g. seamless movement along the steps of the treatment cascade as an essential factor defining quality of interventions).

#### **MEANINGFUL ENGAGEMENT OF KEY AFFECTED POPULATIONS**

The focus on promoting the pragmatic and evidence-based rationale for meaningful engagement at various levels, factoring engagement in the program design including employment of KAP members in direct service delivery as well as KAP involvement in program management and governance.

### **GENDER EQUALITY**

Specific focus on understanding and managing the influence of gender norms and stereotypes on risk and vulnerability, ensuring that the gender composition of the program beneficiaries reflects the gender composition in the target population, ensuring gender literacy of the key stakeholders and service providers.

#### HUMAN RIGHTS BARRIERS TO ACCESSING HEALTH SERVICES

Specific focus on advocating access of marginalized communities to essential services such as substitution maintenance treatment and needle and syringe programs, elimination of inhumane approaches (such as forced rehabilitation of PWID and cruel treatment of KAPs by law enforcement personnel).

#### **COMMUNITY SYSTEMS STRENGTHENING**

The specific focus of this area of work relates to the development and functioning of community-based harm reduction services for People Who Inject Drugs (PWID) and community-based delivery of HIV prevention and care services to other key populations.

The Alliance Hub offers support in the development and introduction of innovative outreach models targeting specific segments of key populations and linking the clients to essential HIV prevention, care and treatment services. Segments, tailored interventions, capacity development of service delivery organizations (complete cycle starting with rapid participatory assessments, intervention design, implementation, finance management, PSCM, monitoring and evaluation, human resource development, access to technical support).

#### MONITORING, EVALUATION AND RESEARCH AT VARIOUS LEVELS

- Developing national and program-specific M&E plans, indicator frameworks, costed M&E work plans, data flow schemes, and other elements of a sound M&E system.
- Adaptation and roll-out of up-to-date software for simplified collection, analysis and reporting of data on service delivery to key populations SyrEx Cloud.
- Development of data collection and reporting forms and tools.
- Development and implementation of national surveys and surveillance and operational research.
- Development and implementation of project / program evaluation.

# The TS can be provided in the forms of:

- Individual TS, including consultations, mentoring, supervision, internships.
- Group TS, including training sessions, workshops, study groups, educational programs, strategic planning.
- Distant TS, provided via online communication and work with documents.
- Network TS, including experience exchange, conferences, joint projects, peer reviews, etc.
- Experience exchange trips.
- Methodological resources development.

#### B Who is eligible to request such TS?

AC provides TS in the area of public health to all kinds of organizations: NGOs, community-based organizations, consortiums, platforms, different kinds of other organizations, including those working on commercial basis, upon their request etc. to all Russian-Ukrainian and English-speaking countries worldwide.

#### How to request TS?

To request TS a recipient should send detailed Terms of Reference (ToR) with the objectives, tasks, outcomes expected and timelines to the focal point of AC. Afterwards the focal point gets in touch with the potential recipient and discusses all the details of the TS. When all the parts of the ToR are discussed AC offers a budget of such TS. Normally the overall process doesn't take longer than two weeks including signing the contract.

AC accepts queries either in Russian or Ukrainian or English.

# TS available to support the meaningful involvement of civil society and communities' representatives into the Global Fund HIV / TB grants implementation

The Eurasian Coalition on Male Health (ECOM) is one of the pre-qualified technical assistance providers<sup>1</sup> under the Global Fund's Technical Assistance Programme on Communities, Rights, and Gender (CRG). ECOM is eligible to provide support to civil society and community organizations to ensure their meaningful engagement in Global Fund-related processes, with a focus on the following areas:

- Engagement in-country dialogue processes;
- Funding request development;
- Grant-making;
- Grant implementation.

Under this programme, civil society members and community organizations are encouraged to apply for technical support in the following areas:

- Situational analysis and planning;
- Engagement in-country dialogue processes;
- Program design and development;
- Monitoring and oversight of the grant implementation activities;
- Engagement in the development of transition and sustainability strategies.

#### 🗳 Who is eligible to request TS?

The following stakeholders from countries eligible for Global Fund funding as well as from countries covered by the activities within the Global Fund regional grants:

- Key population networks and organizations
- Youth-led networks and organizations
- Women's networks and organizations
- Networks or organizations of people living with HIV or affected by tuberculosis or malaria
- Civil society networks and organizations led by or working with other affected communities (e.g. migrants, refugees, miners).

**<sup>1</sup>** Technical assistance is provided by non-governmental organizations, including key population-led communities and networks, universities, and civil society organizations, which have been selected through an open competition procedure based on their demonstrated skills and competencies in the CRG-related areas.

Applicants are required to complete the CRG Technical Assistance Request Form and contact the EECA Regional Platform for Communication and Coordination, hosted by the Eurasian Harm Reduction Association (EHRA), at eecaplatform@harmreductioneurasia.org for assistance in formatting the request prior to submission to the Global Fund.

The completed request form, reviewed by the EHRA, has to be submitted via email to crgta@theglobalfund.org. The request will be assessed by the CRG Department of the Global Fund Secretariat jointly with the Global Fund Country Team and a technical support provider will be appointed.

Technical support will be available from January 2021 to December 2023 for requests related to HIV, tuberculosis, and malaria, as well as resilient and sustainable health systems (RSSH).

### Other TS options available

ECOM offers technical assistance on the following components:

• Strengthened organizational capacity of the LGBT organizations and networks working in the field of health care.

What kind of support we can offer: organizational capacity assessments, development of those policies and procedures important for the organization, strategic and operational planning, etc. What is NOT SUPPORTED: equipment procurement.

Support for human rights activities.
What kind of support we can offer: training on human rights issues, assistance in writing reports to UN agencies/committees, assistance in developing draft laws, legislative reviews, etc.
What is NOT SUPPORTED: routine monitoring of rights violations.

# TS available to support the meaningful involvement of civil society and communities' representatives into the Global Fund HIV / TB grants implementation, as well as COVID-19 pandemic related TS

The involvement of civil society into Global Fund related processes is one of BACKUP's priorities, hence TS is available to civil society organizations. Also, BACKUP has limited resources to support projects that address the COVID-19 pandemic within the scope of our main objective, i.e. strengthening and supporting government and civil society organizations in their capacity to use funding from global health financing mechanisms, such as Global Fund, to strengthen their health systems, and sub-objectives. The project goals should be to strengthen health systems in the medium- or long-term and proposals should be aligned with and endorsed by the entity coordinating the COVID-19 response at the national level. BACKUP offers several resources to support, including technical experts, financial support and the STAGE approach for TS combined with long-term capacity development (typically between 6 and 18 months).

In Kyrgyzstan for example, BACKUP provided COVID-19 response support for the improvement of infection prevention and control in the Kyrgyz state penitentiary system through provision of hygiene articles and gloves and an accompanying information campaign conducted by BACKUP Health and AIDS Foundation East-West (AFEW) in the penitentiary system including audio and video materials in Russian and Kyrgyz. Likewise, BACKUP provided peer to peer trainings for personnel of the national TB reference laboratory, and external quality assurance through the WHO-Supranational TB Reference Laboratory in Munich-Gauting.

## 🖽 Who is eligible to request such TS?

BACKUP can implement TS projects with Country Coordinating Mechanisms, ministries and public health institutions, governmental grant implementing agencies, and national civil society organisations from **Kyrgyzstan**, **Tajikistan** and **Uzbekistan**.

If your organisation has not had a financing contract with BACKUP or another GIZ project in the past 12 months, GIZ requires a commercial suitability review to assess whether a contract is possible and, if so, what kind of contract. The first step in this process is the self-disclosure form which you submit along with the project proposal. Next, GIZ staff or contracted auditors will conduct the review. This may include a visit to your organisation's office or a request to send certain documents, such as a legal registration. Once concluded, you will be informed about the results of the review. If your organisation has had a financing contract with BACKUP or another GIZ project in the past 12 months, please make sure to point this out in your communication with BACKUP. This may enable us to conduct a lighter review or skip the review process altogether.

## How to request TS?

Project development with BACKUP is an iterative and collaborative process. Rather than requesting one complete project proposal, which is then approved or declined, BACKUP asks that you first submit a very brief project outline. BACKUP then provides feedback and, if the project promises to be a good fit, may invite you to develop a more detailed project proposal. A submitted proposal may then go through additional revisions based on feedback and advice from BACKUP technical advisers before being finalised. You can find more details on the process in the next section. BACKUP asks the following questions when considering a project proposal. BACKUP can advise you on these as you develop your proposal:

- Does the project contribute to BACKUP's objectives?
- How does the project address BACKUP's cross-cutting priorities, human rights, gender, equity and value for money?
- What does the available evidence say about the urgency of the issue the project aims to address? About the effectiveness of the proposed approaches? About the sustainability of the proposed measures?
- Is the proposal (including, for example, the monitoring concept and terms of reference) technically sound and coherent?
- Is your organisation well-placed to implement the project?

The first step in developing a project with BACKUP is the project outline. It is a one-page form in which you can provide a short overview of the project you wish to propose. You can submit the form to backup@giz.de or directly to a BACKUP adviser with whom you may already be in contact. A BACKUP adviser will then provide feedback and, if the project appears to be a good fit for BACKUP's objectives, the adviser may then invite you to develop a more detailed project proposal.

# Global Fund "Breaking Down Barriers" Initiative

Global Fund Strategy (2017-2022) Strategic Objective 3(c) commits the Global Fund to support all countries that apply for grants to include and scale up programs to remove human rights-related barriers to health services. Expanding these programs will ensure that the health services supported by the Global Fund reach those living with or vulnerable to the diseases, increasing the effectiveness of Global Fund grants.

As part of efforts to operationalize the Global Fund's Strategic Objective 3(c), the Global Fund has embarked on a major strategic effort, Breaking Down Barriers initiative, aiming for comprehensive programs to remove human rights-related barriers to health services in national responses to HIV, TB and malaria.

Through this initiative, the Global Fund is providing intensive support to 20 countries where needs, opportunities, capacities and partnerships provide real possibilities for scale-up that will result in important gains for the health of those affected<sup>2</sup>.

This intensive support takes the forms of: (a) provision of USD 41 million in 2020-2022 cycle as matching funds for programs to reduce human rights-related barriers to services; (b) assessing impact of scale-up through baseline, mid-term and end-term assessments; (c) multi-stakeholder processes in country to review the assessments and develop and fund jointly national strategic plans for a comprehensive response to the barriers; (d) technical assistance for implementation of quality programs<sup>3</sup>, deployed through the Human Rights Strategic Initiative; and (e) where possible, mathematical modeling to inform scale-up and impact of the programs. The 20 countries range across Global Fund regions and include two countries from EECA region: Kyrgyzstan and Ukraine.

# TS available to support the meaningful involvement of civil society and communities' representatives into the Global Fund HIV / TB grants implementation

The Global Fund is making available medium and longer-term technical assistance in implementing programs and interventions to reduce human rights-related barriers to HIV, TB and malaria services. In particular, the technical assistance will support:

- Implementation of evidence-based and effective combinations of programs/interventions to reduce human rights-related barriers to accessing health services within the context of HIV, tuberculosis and malaria epidemics;
- Integration such programs/interventions into, existing prevention and treatment programs, and national strategies against HIV, TB and malaria, so as to make prevention and treatment programs more effective and equitable;
- Assessing capacity gaps and TA needs, and building capacity of communities and community-based organisations, as well as health systems and state implementers to effectively design, implement, monitor and evaluate programs to address human rights-related barriers;
- Monitoring and evaluation of programs to address human rights-related barriers.

Technical assistance is provided by individuals and organizations – including key population networks, universities and civil society organizations – that were pre-selected through an open tender process for their demonstrated skills and capacities on human rights competencies.

## 🗳 Who is eligible to request TS?

UNAIDS has established a Technical Support Mechanism (TSM) to enable high quality technical assistance (TA) provision to accelerate AIDS response implementation, including the Global Fund grants, towards the Fast-Track Targets and the 2016 Political Declaration on HIV and AIDS response Goals.

The TS is done through the Technical Assistance Fund (TAF) which is a country demand driven but centrally managed instrument which finances the provision of technical expertise and assistance through deploying consultants.

UNAIDS TSM has also TS for COVID-19 related areas which aims to support countries in ensuring HIV services are not disrupted by COVID-19. We have also supported countries in their C19RM applications. Funds will be available for such requests from the middle of the second quarter of 2021.

#### B Who is eligible to request such TS?

In principle, some Fast-Track countries in EECA like Ukraine and exceptionally, countries which recently received Global Fund support - and in which country partners are struggling with the transition to domestic resources - may request for Technical Assistance.

But due to the negative impact of the pandemic, countries with the most significant levels of specific service interruption and populations in HIV testing and linkage to ART and in prevention services, high burden of COVID-19 cases and weak health systems and/or active humanitarian crises are eligible to apply for TS.

The following organizations (Government and CSO/NGO partners) in the priority countries can apply for TS if they:

• Have a focus on and investment in expanding the community response (community systems strengthening and community-led responses).

- Have strong analysis and/or well-structured interventions to address stigma, human rights, and gender barriers.
- Pay strong attention to key and vulnerable populations.
- Have substantial progress in prioritizing prevention activities, including the introduction and/or expansion of new prevention technologies, such as pre-exposure prophylaxis (PrEP).
- Have the aim of strengthening key population targeting and programming.
- Have AGYW (Adolescents Girls and Young Women) focused initiatives.
- Work on the implementation of the Stigma Index 2.0, and expansion of community led responses.

### How to request TS?

The request for TS usually originates from national stakeholders (CSOs/NGO, Government etc.), and is channeled through UNAIDS Country Offices (UCO). A letter is addressed to the UNAIDS Country Director requesting for technical support. The Country Director/TSM Focal Point will examine the request and will coordinate the preparation, completion, and submission of the Technical Assistance Fund (TAF) application form to the UNAIDS Regional Support Team (RST) for review and approval. The Regional office will thereafter submit the request to the TSM Team for processing. (See TAF Process below).



In terms of deadlines, it is ideal if the request for support can be requested to the UCO as early as possible (many months in advance) given that at the beginning of each year, the UCO develops an annual plan for the year for technical support so all requests should be put into this plan. TS is for a maximum of 3 months.

In terms of language, English or French is encouraged as the forms are processed and reviewed through various units throughout the organization at the country, regional, HQ level.

WHO may provide TS, including to civil society organizations, through publishing and dissemination of technical guidance, organizing trainings, webinars, workshops, and other types of meetings on the following topics:

#### B Who is eligible to request such TS?

The WHO Regional Office for Europe (WHO/Europe) is one of WHO's six regional offices around the world. It serves the WHO European Region, which comprises 53 Member States: http://www.euro.who.int/en/countries. WHO/Europe provides technical assistance primarily to its Member States, represented by Ministries of Health.

WHO also advocates and facilitates full inclusion and involvement of the civil society, including organizations representing vulnerable populations into national response to the COVID-19 pandemic.

WHO also advocates and facilitates full inclusion and involvement of the civil society, including patients' organizations into national response to HIV and TB.

Civil society organizations working in the area HIV, TB and viral hepatitis and regional network can approach WHO/Europe directly or through its Country Offices regarding possibility of technical support.

#### How to request TS?

There is no special procedure to request TS. Requests can be sent to the focal points (see above) by email in English or Russian language.

# Other TS options available

WHO may provide TS, including to civil society organizations, through publishing and dissemination of technical guidance, organizing trainings, webinars, workshops, and other types of meetings on the following topics:

- HIV, TB and viral hepatitis surveillance and strategic information
- HIV, TB and viral hepatitis prevention, including innovative prevention interventions
- HIV, TB and viral hepatitis testing, treatment and care
- Implementation science in the area of HIV, TB and viral hepatitis prevention and response.

WHO may provide TS in development of the National Strategic Plans (NSPs). It includes support in the country consultation process to ensure involvement of all national and international stakeholders, including civil society and community organization and all sectors involved in the disease response in development, implementation and M&E of NSPs.

WHO may provide TS on the regional level, or on country level – through WHO Country Offices where present, and also through the network of WHO Collaborating Centers: https://www.who.int/about/partnerships/collaborating-centres.
