# CE SI **Short-Term TA** for Community Engagement in GC8 Funding Request Development and Grant-making

What can short-term TA cover?	LOE
<p><b>Track A. Virtual or face-to-face community consultation(s) to inform priorities for GC8 funding request development</b></p> <ul style="list-style-type: none"> <li>• Preparation and kick-off</li> <li>• Desk review</li> <li>• Rapid review of GC7 grants/programs</li> <li>• Community consultations (virtual or face-to-face) to identify priorities</li> <li>• Costing support</li> <li>• Reporting and validation</li> <li>• Mentorship during FR writing</li> </ul>	<p><b>Max. 20-30 expert days</b> (depending on # of disease components)</p>
<p><b>Track B. Coordinating input into GC8 grant-making</b></p> <ul style="list-style-type: none"> <li>• Community consultation (virtual or face-to-face)</li> <li>• Mentorship</li> <li>• Briefing on grant-making outcomes</li> </ul>	

## How to Request TA?

- Discuss among CCM community and civil society representatives the need for TA.
- Reach out to [Learning Hub](#) in your region to request the TA form.
- Identify a community/CS TA focal point, collectively complete the TA request form, and share it with the Learning Hub for review.
- Inform the CCM Secretariat about the TA.
- Submit the final TA request to [ceta@theglobalfund.org](mailto:ceta@theglobalfund.org) (copying CCM Secretariat and CCM community/CS representatives involved in the TA).
- Please make sure to submit the request at least six months before your GC8 submission window.

**Who can apply?** Countries eligible for Global Fund GC8 funding.

# CE SI: Rapid Engagement Support (provided by Learning Hubs)

Illustrative Activities for Rapid Engagement Support	Budget
<p><u>Meeting and participation support:</u></p> <ul style="list-style-type: none"><li>• Logistics costs for <b>face-to-face or virtual consultations</b> with community/CS CCM members and their constituencies to identify priorities for GC8 funding requests.</li><li>• Limited support for <b>community participation</b> in decision-making meetings (e.g., CCM, writing retreats).</li></ul>	
<p><u>Contract consultant to:</u></p> <ul style="list-style-type: none"><li>• Compile and <b>review relevant documents</b> (e.g., GC7 grant performance/reporting, assessments of programmatic interventions, community data, CRG related assessments) and develop a 2-page rapid contextual analysis.</li><li>• Prepare, facilitate and document a <b>community consultation</b>.</li><li>• <b>Virtual mentorship</b> during funding request writing or grant-making (e.g., during review of draft/final funding request or budgets for CCM endorsement)</li></ul>	<p><b>Up to US\$ 5,000</b> (depending on available budget)</p>

## How to Request this Support?

- Discuss among CCM community and civil society representatives the need for rapid engagement support.
- Reach out to [Learning Hub](#) in your region to signal your interest.
- Identify a community/CS focal point organization and develop a short concept and cost proposal using the template provided by the Learning Hub.

**Who is eligible?** Countries eligible for Global Fund GC8 funding.
