

Overview of Technical Assistance Providers

The Community, Rights and Gender Strategic Initiative (CRG SI) has pre-qualified twenty-six (26) civil society and key population networks and organizations as CRG technical assistance providers for the 2021-2023 implementation period. These organizations were selected through an open and competitive tender process, to ensure providers have a strong track record and relevant expertise in relation to human rights, gender, community responses and community systems strengthening. Technical assistance providers will be selected in line with the specific requirements of each technical assistance request and based on their technical and regional expertise, language of delivery, availability, ability to identify national and regional community experts and to contribute to their skills transfer, past performance and value for money.
