



Country	Assignment Scope			
Tajikistan	To conduct a situational assessment of barriers to TB services for women and develop recommendations on how to address them (phase 2)			
Russia	To ensure the meaningful involvement of the civil society and communities' representatives into the national dialogue processes in Russia for the purpose of the development of the new HIV proposal to the Global Fund.			
Albania	To support the development of an analysis of efficiency and effectiveness of services provided to KP by CSOs			
Belarus	To support the participation of representatives of CSOs/CBOs in the development of the upcoming funding request			
Georgia	To support meaningful engagement of TB and HIV community groups in the development of the Georgia HIV/TB funding request			
Tajikistan	To engage local CBOs/NGOs in CLM of HIV and TB services to detect and address gender, stigma and human rights issues that hinder access of key populations to HIV and TB prevention and treatment.			
Russia	To strengthen the participation of Key Community Forums in GF HIV grant implementation.			
Azerbaijan	To support civil society improving the quality of civil society services related to HIV, through the introduction and use of international IDUIT tools.			
Georgia	To strengthen the meaningful involvement of PWID community into the Global Fund related processes in Georgia.			
Ukraine	To obtain relevant data reflecting the current reality of the reproductive health situation of women with HIV to inform GF programming.			
Azerbaijan	To ensure effective participation of civil society in Global Fund processes at the national level by improving the quality of HIV services provided by civil society, through the introduction and use by civil society of international SWIT tools.			
Kyrgyzstan	Assess the impact of the new legislation on access to HIV and TB services for PWID and develop at advocacy action plan linked to catalytic funding and designed to overcome legal barriers for PWID			
Moldova	Assess the impact of national drug policies on Global Fund grants, and develop a set of drug policy recommendations and an advocacy strategy to influence existing drug policies to improve the HIV response.			
Kazakhstan	Increase participation and involvement of ex-prisoners and CSOs working with prisoners in Global Fund related processes through awareness raising, development of an engagement plan and identifying priorities for GC7			
Serbia	Capacity strengthening of the CSOs in terms of knowledge and practices related to GF to increase scope and quality of HIV and TB prevention and support services at the national level.			
Tajikistan	Strengthen the capacity and meaningful participation of civil society and communities of key populations in the process of national dialogue for GC7


CRG Technical Assistance does <u>NOT</u> support:
