

Sustainability of opioid agonist therapy programmes in Belarus, the Republic of Moldova, Tajikistan and Ukraine in the context of transition from Global Fund support during 2020–2023

On 16th October 2024 the <u>Harm Reduction Journal</u> has published an <u>article</u> <u>Sustainability</u> of opioid agonist therapy programs in Belarus, the Republic of Moldova, Tajikistan and Ukraine in the context of transition from Global Fund support during 2020–2023.

The study concludes that after 20 years, OAT sustainability in the four countries remains at risk and requires further planning and management. Technical partners and donors should continue supporting this work through the dual lenses of HIV and drug policy. Realistic expectations and new solutions for sustainability are needed for conflict-affected territories. Reports from Serbia, Georgia, Moldova and Tajikistan: Public Commitments to Ensure Sustainability of the HIV Response Among Key Populations in the Context of Transition from the Global Fund

The reports from **Serbia** (English), **Georgia** (English), **Moldova** (English | Russian) and **Tajikistan** (English | Russian) on the results of re-assessment of the progress with fulfillment of the government commitments to ensure sustainability of HIV responses among key affected populations (KAP) in the context of transition from Global Fund support to national funding have been published. Assessment was conducted by EHRA with the SOS 2.0 project using the updated methodology being developed and piloted in 2020 – 2021.

















Growing trend of governments to impose restrictions on NGOs, including through so called "foreign agents" law has impact on many levels. According to the Global Fund countries where civic space is restricted account for a large share of the burden of the three diseases that the Global Fund focuses on. 
