

# The Global Fund's 8th Replenishment Summit resulted in US\$11.34 billion raised



"Global Fund Partners Demonstrate Unity and Resolve to Sustain Progress and Strengthen Global Health Security" says the news release of the Global Fund on 21st of November 2025 after its Eighth Replenishment Summit in Johannesburg, South Africa, co-hosted by the governments of the Republic of South Africa and the United Kingdom on the margins of the G20 Leaders' Summit.

Despite one of the most turbulent geopolitical and economic years in recent memory, partners around the world pledged US\$11.34 billion to sustain the fight against AIDS, tuberculosis and malaria, save millions more lives, and strengthen systems for health.

The pledging for the 8th Replenishment is not yet over – a number of countries, like Japan, France and the European Commission, indicated that they would pledge at a later date.
